### **Terms & Conditions**

1. A cleared space of at least 100 square feet is required for one dancer; a bit more space is needed for 2-3 dancers, and for 4-6 dancers at least 150 square feet is required.
2. For performances involving flamenco a raised wooden stage is best, or at the very least a wooden floor. This is needed for optimal sound due to the percussive nature of flamenco dancing. If your event is at a banquet hall they may be able to provide this for you. Also, please note that the floor will get scratched. Therefore, please discuss these details with the coordinator/manager at the location of the event.
3. Dancer(s) require a secure room to change and leave their belongings.
4. Dancer(s) should have immediate access to the change room, as hanging around in costume after her performance is not acceptable.
5. Dancer(s) are not to interact with the audience before or after their performance; we are there for the sole purpose of performing.
6. A proper music system is required. A regular CD player or boom box is not sufficient enough.
7. A professionally dressed escort may accompany the dancer(s), a seat must be provided for that escort and no fees will be demanded of the escort for admission.

8. In the event of any inappropriate behavior, it is at the dancer(s) discretion to immediately terminate the performance and full payment will be demanded.
9. Whether a show is 5-30 minutes long, the charge is for 30 minutes.
10. Accurate arrival and performance times are required. Some dancers have more than one performance commitment per day/night and require adequate travel time. Beyond a 30-minute grace period, there is a charge of \$50 extra per 15-minute interval. If dancer(s) do have another commitment, and the 30-minute grace period infringes on getting to the second commitment on time, the dancer(s) have the right to cancel show in question and demand full payment before their departure.
11. Date of Service will not be held until both non-refundable deposit and signed contract have been received by Alhambra Dance Co.
12. Alhambra Dance Co. reserves the rights to refuse to perform for outside engagements if the weather is or becomes in anyway threatening to the dancer(s) and their costume(s).
13. All transportation/parking fees are additional to services provided and should be validated and honored by the client.
14. If main performer/instructor falls ill or is unable to perform, a dancer/instructor of the same caliber will be sent in their place.
15. A Client's failure to abide by the Terms & Conditions gives dancer(s) the right to refuse to perform and still get paid in full.
16. Dancer(s) will not perform at any all male parties under any conditions.
17. Cancellation policy:
  - \*For bookings made way in advance of event:
    - Deposit is non-refundable and due within 1 month of event date
  - \*For bookings made from days to 1 month before event date:
    - Deposit is non-refundable and due immediately
  - \*Cancellation must be made one week before the performance date, otherwise a 50% cancellation fee is due
  - \*Cancellations made within 48 hours of the performance date will be subject to a 100% cancellation fee.

Please retain one copy for your personal records and return the original copy, with the **deposit** balance owed, to the mailing address provided above. Note: The date of service will **NOT** be held, until both the contract and the deposit are received. Please make all cheques payable to: Kelly Enston
